

2017 & 2019 OPIOID PRESCRIBER SURVEY: PRELIMINARY RESULTS

BACKGROUND

- The NM SPF Rx grant, funded by CSAP
- Goal: Reduce unintentional overdose death due to prescription painkillers by:
 - raising awareness about the dangers of sharing medications and work with pharmaceutical and **medical communities** on the risks of overprescribing to young adults.
 - raising community awareness and bringing prescription drug abuse prevention activities and education to schools, communities, parents, prescribers, and their patients.

OBJECTIVES

- Objective 1.1: Reduce self-reported misuse of prescription opioid drugs among youth and young adults 12 to 40 by 10% in Bernalillo County by September 2021.
- **Objective 1.2:** Increase timely and effective use of the PMP by providers and pharmacists by increasing the percentage of PMP checks every 3 months by providers prescribing opioids to chronic opioid users and increase the percentage of PMP checks for new opioid patients.
- **Objective 1.3:** Decrease the incidence of risky prescribing practices by demonstrating a decrease in number of new chronic opioid prescription patients -- defined as reduction (within aggregate PMP data) in number of <u>patients with opioid prescriptions covering</u> 90 to 163 days ("episodic") and more than 164 days ("full time") by 25% by September 2021.

OBJECTIVES

- **Objective 1.4:** Increase awareness by 10% within the pharmaceutical and medical communities in Bernalillo County of the risks of overprescribing, as measured by prescriber self-reporting by September 2021.
- Objective 1.5: Increase use of PMP data in state health and behavioral health planning processes, in at least two additional arenas, as observed and reported during the period of project through September 2021.
- **Objective 1.6:** Decrease self-reported sharing of prescription opioids in Bernalillo County by 5% by September 2021.
- **Objective 1.7:** Increase proper and safe storage of prescription opioids in the home in Bernalillo County by 5% by September 2021.
- **Objective 1.8:** Increase perceived risk of harm of prescription opioid misuse and abuse among youth, parents, and young adults in Bernalillo County by 5% by September 2021.

NM OPIOID PRESCRIBER SURVEY

- On-line survey of NM medical providers registered in the NM PMP
- Worked with the NM Board of Pharmacy who manages/controls the PMP system it reach prescribers
- Wanted to see what prescribers know & don't know, what they're doing, how they're making decisions, what they need/want with respect to training.

METHODS- YEAR 1 (2017)

- 9,485 email invitations went out to registered PMP users
- Follow-up/reminder emails were sent
- 1,672 completed survey on-line
- 1,380 prescribe opioids and/or benzos in their practice
- 18% response rate

METHODS- YEAR 2 (2019)

- 7066 email invitations went out PMP registered users who prescribed opioids in the past 12 months (224 were not good addresses or indicated that survey was not applicable to them)
- Follow-up/reminder emails were sent
- 1,396 Completed survey on-line
- 1,128 prescribe opioids and/or benzos in their practice
- 20% response rate


SAMPLE CHARACTERISTICS

- 33 counties were represented in 2017
- 32 counties represented in 2019
- 46.3% in 2017 & 41.4% in 2019 practiced in Bernalillo County followed by Doña Ana and Santa Fe Counties
- Average number of years in practice for 2017 sample was 18.9 years and in 2019 it was 19.0 years






IN YOUR ROLE AS A HEALTH CARE PROVIDER, DO YOU EVER...(2019)




IN YOUR ROLE AS A HEALTH CARE PROVIDER, DO YOU EVER... (2019 QUESTION)




DATA WAIVER REGISTRATION (2019 QUESTION)






How many patients are you currently treating under your waiver? (N=170)




















TO WHAT EXTENT ARE YOU COMPLIANT WITH PMP UTILIZATION REGULATIONS?*





HAVE YOUR PRESCRIBING PRACTICES CHANGED OVER THE LAST 12 MONTHS?




WHY HAVE YOUR PRESCRIBING PRACTICES CHANGED? (2019 QUESTION, N=1395)

- Pre & Post intervention data from opioid prescriber
- Providers say they are most often doing the educating on potential risks associated with opioid use
- Some progress is still needed in pre-screening of patients on potential risk factors
- Some differences over time in respect to practices
 Particularly Narcan prescribing because of new law
- Opportunities remain to provide additional training to prescribers and perhaps to those who could take on some of the education burden
