

Build or increase the ability to effectively increase protective/resiliency factors and reduce risk factors (contributing factors) in Intervening Variables identified in assessment.



Capacity Contractual Training Requirements (SAPT and PFS 20)



Each full-time preventionist paid out of the grant shall participate in a minimum of 30 CEUs/hours of trainings

The trainings shall include, but not be limited to, Ethics for the Prevention Professional (to be taken every two years) and the Substance Uuse Prevention Skills Training (SUPST).



Each staff person paid out of the grant at .25 FTE or higher, submit a SEPARATE Training Plan/Form C to OSAP. Courses must be restricted to substance abuse prevention and Form A/B competencies.



A least one staff person who has or will pursue and attain Certified Prevention Specialist status within two years (SAPT)

The Training System Supports Your Capacity Development



Funded by the OSAP to increase the capacity of preventionists to deliver effective prevention services to their communities.



All training provided by the training system is approved for Form C and can help you complete Form A/B.



All training provided by the training system counts towards Certified Prevention Specialist training requirements.

Who Can Use The Training System?

• Each OSAP funded program is eligible to have 5-7 people who can attend training for free. These should be people who are actively engaged in helping your OSAP funded program be successful

HOW TO BECOME AN OSAP 'CORE TEAM' MEMBER

What is the core team?

- OSAP funds a training system that provides training needed to get certified as a Prevention Specialist as well as providing knowledge and skills needed to successfully complete your scope of work.
- A benefit of being funded by OSAP is you have access to this training for FREE.
- Each program is allowed up to 7 people on their core team. Your core team should be the staff of the OSAP program and anyone else in your community that helps with your scope of work and could benefit from training.
